Steve Mitchell reiterated to Mrs. Langer that the meters were installed at no cost to any of East Garrett customers and that the meters were past due for replacement. The new meters are smart meters, and provide more accurate readings. She also wanted to know when the base cost of the meters was going to be lowered and why can't we have a tier system. John Wade explained that we are considered one of the lowest in billing for utilities and that we are not treated like a tier system, therefore we cannot set up billing as one.

Mr. Adams introduced himself and wanted to help work with East Garrett on developing our area and just wanted to meet and greet with the board.

the pressure of a hire hydrant near that location, and an Engineer will need to be involved now on the expansion (if capable) of the existing line. Cost of the upgrade will be responsible by the customer(s) that are needing it.
